**GRANT OF TRADEMARK SECURITY INTEREST**

March 25, 2009

**WHEREAS**, EDELBROCK CORPORATION, a Delaware corporation ("**Grantor**"), owns and uses in its business, and will in the future adopt and so use, various intangible assets, including the Trademark Collateral (as defined below); and

**WHEREAS**, pursuant to the Letter of Credit and Reimbursement Agreement dated as of May 1, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "**Reimbursement Agreement**"; the terms defined therein and not otherwise defined herein being used herein as therein defined), by and between Edelbrock Permanent Mold, LLC, a California limited liability company ("**Edelbrock Permanent**"), and Bank of America, N.A., as Bank under the Reimbursement Agreement (in such capacity, "**Secured Party**"), among other things, Bank has issued an irrevocable direct pay letter of credit to provide security for the obligations of Edelbrock Permanent under the loan agreement, dated as of May 1, 2007, by and between Edelbrock Permanent and The Bank of New York Trust Company, N.A.; and

**WHEREAS**, Grantor has executed and delivered the Continuing and Unconditional Guaranty dated as of May 1, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "**Guaranty**") in favor of Secured Party, pursuant to which Grantor has guaranteed the prompt payment when due of all obligations of Edelbrock Permanent under the Reimbursement Agreement and the other Related Documents; and

**WHEREAS**, pursuant to the terms of a Security Agreement dated as of May 1, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), by and between Grantor and Secured Party, Grantor created in favor of Secured Party a security interest in, and Secured Party has become a secured creditor with respect to, the Trademark Collateral; and

**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Security Agreement, to evidence further the security interest granted by Grantor to Secured Party pursuant to the Security Agreement, Grantor hereby grants to Secured Party a security interest in all of Grantor's right, title and interest in and to the following, in each case whether now or hereafter existing or in which Grantor now has or hereafter acquires an interest and wherever the same may be located (the "**Trademark Collateral**"):

(i) all rights, title and interest (including rights acquired pursuant to a license or otherwise) in and to all trademarks, service marks, designs, logos, indicia, tradenames, trade dress, corporate names, company names, business names, fictitious business names, trade styles and/or other source and/or business identifiers and applications pertaining thereto, owned by such Grantor, or hereafter adopted and used, in its business (including, without limitation, the trademarks set forth on Schedule A annexed hereto) (collectively, the "**Trademarks**"), all registrations that have been or may hereafter be issued or applied for thereon in the United States and any state thereof and in foreign countries (including, without limitation, the registrations and applications

set forth on Schedule A annexed hereto), all common law and other rights (but in no event any of the obligations) in and to the Trademarks in the United States and any state thereof and in foreign countries, and all goodwill of such Grantor's business symbolized by the Trademarks and associated therewith; and

(ii) all proceeds, products, rents and profits of or from any and all of the foregoing Trademark Collateral and, to the extent not otherwise included, all payments under insurance (whether or not Secured Party is the loss payee thereof), or any indemnity, warranty or guaranty, payable by reason of loss or damage to or otherwise with respect to any of the foregoing Trademark Collateral. For purposes of this Grant of Trademark Security Interest, the term "proceeds" includes whatever is receivable or received when Trademark Collateral or proceeds are sold, licensed, exchanged, collected or otherwise disposed of, whether such disposition is voluntary or involuntary.

Grantor does hereby further acknowledge and affirm that the rights and remedies of Secured Party with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
