AGREEMENT TERMINATING TRADEMARK LICENCE AGREEMENT

The Agreement made this ^{30th} day of December, 2008, by and between RECTICEL S.A. having its registered office at Olympiadenlaan 2, 1140 Brussels, Belgium (hereinafter "Licensor"), and RECTICEL NORTH AMERICA, INC., having its registered office at 1653 Atlantic Boulevard, Auburn Hills, Michigan 48326-1503 (hereinafter "Licensee"),

WITNESSETH:

WHEREAS, Licensor and Licensee are parties to a Trademark Licence Agreement executed February 16, 2004 relating to U.S. Trademark Registrations No. 1,278,464 dated May 22, 1984 for the mark COLO-FAST and No. 2,726,420 dated June 17, 2003 for the mark ARO-FAST; and

WHEREAS, the parties desire to terminate said licence agreement as of the date first written above;


NOW, THEREFORE, in consideration of the sum of one (\$1.00) dollar and other good and valuable consideration, the parties hereto agree as follows:

1. The above-referred to Trademark Licence Agreement dated February 16, 2004 is hereby terminated as of the date first written above.

3. The parties mutually release one another from any and all obligations under and liabilities incurred in connection with the aforesaid Trademark Licence Agreement dated February 16, 2004 through the date of this Agreement.




