**GRANT OF SECURITY INTEREST (TRADEMARK)**

The undersigned, **VEROXY TECHNOLOGY PARTNERS, LLC**, a Massachusetts limited liability company (the "**Grantor**"), and **WEBSTER BANK, NATIONAL ASSOCIATION** (the "**Lender**"), are parties to a Security Agreement, dated as of April 21, 2009 (as amended, supplemented or otherwise modified from time to time, the "**Security Agreement**").

Pursuant to the Security Agreement, the Grantor granted to the Lender a security interest in and to all of the right, title and interest of the Grantor in and to the trademarks listed on Schedule 1, which trademarks are registered in the United States Patent and Trademark Office (the "**Trademarks**"), together with the goodwill of the business symbolized by the Trademarks, and all proceeds thereof, including, without limitation, from any and all causes of action which may exist by reason of infringement thereof (the "**Collateral**"), to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement).

For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grant of the security interest as aforesaid, the Grantor hereby grants to the Lender a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations (as defined in the Security Agreement).


The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Lender with respect to the security interest in the Collateral made and granted hereby are set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. To the extent any provision of this Grant of Security Interest (Trademarks) conflicts with any provision of the Security Agreement, the Security Agreement shall govern.

Upon the satisfaction of the Obligations, the Lender shall, at the Grantor's sole cost and expense, promptly execute, deliver and/or file any and all releases reasonably requested by the Grantor as may be necessary to release the security interests created by the Security Agreement.
