**CONFIRMATORY ASSIGNMENT  
OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

Reference is hereby made to the security agreement (the "IP Security Agreement") executed as of June 29, 2006 by **COLLEGIATE PACIFIC INC. NOW KNOWN AS SPORT SUPPLY GROUP, INC.**, a Delaware corporation ("Grantor") in favor of **MERRILL LYNCH BUSINESS FINANCIAL SERVICES INC. AKA MERRILL LYNCH CAPITAL (MERRILL LYNCH BUSINESS FINANCIAL SERVICES INC. NOW KNOWN AS GE BUSINESS FINANCIAL SERVICES INC.)**, a Delaware corporation with an address at 222 North LaSalle Street 17th Floor, Chicago, IL 60601 (the "Original Secured Party") as recorded in the United States Patent and Trademark Office at Reel 3350/ Frame 0538 on July 18, 2006, pursuant to which the Grantor assigned, granted, conveyed, pledged, hypothecated and transferred to the Original Secured Party a security interest in and to all of Grantor's right, title and interest in and to the trademarks set forth on Schedule 1 attached hereto, and the goodwill associated therewith, as more fully described in the IP Security Agreement (collectively, the "IP Collateral"); and

**WHEREAS**, pursuant to the Assignment Agreement, dated as of December 29, 2007, (the "Assignment Agreement"), by and between Original Secured Party and **MERRILL LYNCH COMMERCIAL FINANCE CORP.**, a Delaware corporation with an address at 222 North LaSalle Street 17th Floor Chicago, IL 60601 (the "Assignee Secured Party"), Original Secured Party assigned and transferred to Assignee Secured Party all of Original Secured Party's rights, titles and interests under the IP Security Agreement;

**WHEREAS**, Original Secured Party wishes to confirm its assignment and transfer to Assignee Secured Party the IP Security Agreement and the security interest in the IP Collateral thereunder.

**NOW, THEREFORE**, for good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Original Secured Party hereby confirms, subject to the terms of the Assignment Agreement, its assignment to Assignee Secured Party, the IP Security Agreement and Original Secured Party's security interest in the IP Collateral and all other rights of the Original Secured Party under the IP Security Agreement, effective as of December 29, 2007.
