**NOTICE OF RELEASE OF SECURITY INTEREST**

WHEREAS, Jones Apparel Group, Inc. ("Jones") and Wachovia Bank, National Association as successor by merger to Congress Financial Corporation, as agent for itself and The Philadelphia National Bank ("CFC"), entered into a Trademark Security Agreement ("Security Agreement") dated August 28, 1989;

WHEREAS, pursuant to the Security Agreement, Jones granted CFC a security interest in Jones's right, title and interest in and to certain United States trademarks (the "Trademarks"), as security for the payment and performance of certain secured obligations, and to induce the loans to be made and financing agreements to be issued;

WHEREAS, CFC desires to release the Security Agreement and its security interest in the Trademarks and the Collateral;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, CFC hereby relinquishes, releases and terminates any and all liens, security interests, right, title and interest of CFC pursuant to the Security Agreement in the trademarks more fully identified in Schedule A annexed hereto and made a part hereof, together with the goodwill of the business symbolized thereby, without recourse or representation or warranty, express or implied, of any kind and authorizes and requests that the Patent and Trademark Office note and record the existence of the release hereby given.

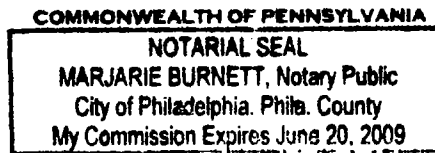
