**RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of April 17, 2009, is made by The Bank of New York Mellon, formerly known as The Bank of New York, as Collateral Agent ("Agent"), for the benefit of Genmar Holdings, Inc. and its subsidiaries (the "Company").

WHEREAS, the Agent and the Company and certain of the Company's subsidiaries were parties to certain trademark security agreements, namely (i) the Trademark Security and Pledge Agreement by and between the Agent and Crestliner, Inc., dated July 19, 1994, (ii) the Trademark Security and Pledge Agreement by and between the Agent and Genmar Industries, Inc., dated July 19, 1994, and (iii) the Grant of Security Interest (Trademarks) by and among the Agent and Genmar IP LLC, JTC Acquisition LLC, Genmar Transportation LLC, Four Winns Boast, LLC, Seaswirl Boats, Inc., Lowe Boats, Inc., Stratos Boats, Inc., Lund Boats, Inc., Genmar Yacht Center, Inc., and Yachtscape LLC, dated July 27, 2001 ((i)-(iii) collectively known hereafter as "Security Agreements");

WHEREAS, the Security Agreements were recorded in the U.S. Patent and Trademark Office;

WHEREAS, pursuant to the Security Agreements, the Company, and certain of its subsidiaries, including Crestliner, Inc., Genmar Industries, Inc., Genmar IP LLC, JTC Acquisition LLC, Genmar Transportation LLC, Four Winns Boast, LLC, Seaswirl Boats, Inc., Lowe Boats, Inc., Stratos Boats, Inc., Lund Boats, Inc., Genmar Yacht Center, Inc., and Yachtscape LLC, granted a security interest in certain trademarks listed in Annex I herein (the "Trademarks") in favor of BONY;

WHEREAS, the Company had pledged the Trademarks to the Agent in connection with certain financings and thus the Trademarks had liens against them in favor of the Agent;

WHEREAS, the Company, in 2002, fully paid off the loans and fully satisfied the financing obligations it owed to the Agent and the Lenders in connection with the Trademarks pursuant to which the liens were granted;

WHEREAS, the Agent did not file a trademark release document with the United States Patent and Trademark Office indicating that the Company satisfied its obligations pursuant to the Security Agreements and that the security interest in the Trademarks had therefore been released by the Agent to Company;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it may have in the Trademarks.

To the extent the Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Company and its successors-in-interest in the Trademarks, such successors-in-interest including, but not limited to the Brunswick Corporation.

The Agent shall at the cost and expense of the Company take all further actions, and provide to the Company and its successors-in-interest, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Company to more fully and effectively effectuate the purposes of this Release.
