WHEREAS, pursuant to the Guarantee and Collateral Agreement, Assignor and Assignees entered into that certain Trademark Security Agreement, dated as of January 22, 2008 (as amended, supplemented or otherwise modified from time to time, the "Trademark Security Agreement");

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on January 29, 2008, at Reel 3706/Frame 0414, Reel 3706/Frame 0370, Reel 3706/Frame 0482, and Reel 3706/Frame 0290;

WHEREAS, pursuant to the Guarantee and Collateral Agreement and the Trademark Security Agreement, as security for the payment or performance, as the case may be, in full of the Obligations, each Assignee granted and pledged to Assignor, its successors and assigns, for the ratable benefit of the Secured Parties, a security interest in, all right, title or interest in or to any and all of the following assets and properties then owned or at any time thereafter acquired by such Assignee or in which such Assignee then had at any time in the future acquired any right, title or interest (collectively, the "Trademark Collateral"):

(a) trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office (or any successor office) or any similar offices in any State of the United States or any other country or any political subdivision thereof; and all extensions or renewals thereof, including those listed on Schedule I hereto (the "Trademarks");

(b) the right to sue or otherwise recover for any and all past, present and future infringements and dilutions thereof;

(c) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements and dilutions thereof); and

(d) all other rights of any kind whatsoever accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each of the above, provided that the grant of the security interest hereunder did not include any application for a Trademark that would be deemed invalidated, canceled or abandoned due to the grant and/or enforcement of such security interest unless and until such time that the grant and/or enforcement of the security interest would not affect the status or validity of such Trademark;

Assignor further agrees to execute and deliver to Assignees any and all further documents and instruments, and do any and all further acts which Assignees (or their agents or designees) reasonably request (at Assignees' sole cost and expense) in order to confirm this Release and Assignees' right, title, and interest in or to the Trademark Collateral.




