REMOVAL OF SECURITY INTEREST

On August 31, 2007, Triax Pharmaceuticals, LLC, a Delaware limited liability company ("Triax") entered into a Grant of Security Interest agreement ("Security Agreement") with Laminar Direct Capital L.P., as Collateral Agent, a Delaware limited partnership located at 10000 Memorial Drive, Suite 500, Houston, Texas 70024 ("Laminar"). The security interest was recorded with the United State Patent and Trademark Office on September 25, 2007 at Reel 3627 and Frame 0111.

The "Security Agreement" was recorded against seven (7) properties including the registrations set forth below ("Astellas Marks"):

U.S. Trademark Registration No. 2136591 issued on 1998-02-17 February 17, 1998 for the mark "LOCOID LIPOCREAM" for use with topical pharmaceutical preparations for the treatment of skin disorders, in International Class 5.

U.S. Trademark Registration No. 1058915 issued on February 15, 1977 for the mark "LOCOID" for use with pharmaceutical steroid preparations for topical use, in International Class 5.

Astellas Pharma Europe B.V. is the true owner of the Astellas Marks, and owner of record of the above Astellas marks. In a Purchase and Sale agreement dated 9 July 2002 between Ferndale Laboratories, Inc. and Triax Pharmaceuticals, LLC which itself is subject to a License, Manufacturing & Supply agreement between Ferndale and Astellas dated 8 May 2002, Triax was granted the right to use the Astellas Marks. The license agreement does not covey any ownership interest in the Astellas Marks to Triax. Triax does not have the right or the ability to grant any type of security interest in the Astellas Marks. Subject to the foregoing, Astellas Pharma Europe B.V., hereby requests removal of the improperly record security interest recorded with the United States Patent and Trademark Office on September 25, 2007 at Reel 3627 and Frame 0111.
