ASSIGNMENT AND ASSUMPTION OF INTELLECTUAL PROPERTY

This ASSIGNMENT AND ASSUMPTION OF INTELLECTUAL PROPERTY ("Assignment and Assumption of Intellectual Property") is made and effective as of April 1, 2009 by PharmaWrite, LLC, Delaware limited liability company ("Assignor") in favor of DesignWrite, LLC a Delaware limited liability company ("Assignee").

NOW, THEREFORE, in consideration of the foregoing, and for good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows.

1. Assignment. Assignor hereby sells, assigns and transfers to Assignee, and Assignee does hereby accept and assume, all of Assignor's right, title and interest in and to the Mark and the Registration.
2. Governing Law. This Assignment and Assumption of Intellectual Property shall be construed and interpreted in accordance with the laws of the State of New York.
3. Further Assurances. Following the execution of this Agreement, the parties shall take all necessary actions to satisfy the terms and conditions hereby established.
