**AGREEMENT AND PLAN OF LIQUIDATION
OF**

EAGLE RADIO, INC.

(A Wholly Owned Subsidiary of Eagle Communications, Inc.)

THIS AGREEMENT AND PLAN OF LIQUIDATION made this 28th day of October, 2003, by and between EAGLE RADIO, INC., a Kansas corporation, with principal offices in Hays, Kansas, (hereinafter called the "Corporation"), and EAGLE COMMUNICATIONS, INC., a Kansas corporation, with principal offices in Hays, Kansas, (hereinafter called the "Stockholder")

WITNESSETH:

WHEREAS, Stockholder owns 2,163.915 shares of common capital stock of the Corporation, which shares constitute all of the issued and outstanding common capital stock of the Corporation, and

WHEREAS, Stockholder desires to approve, authorize and consent to the plan for complete liquidation under which all of the assets of the Corporation will be distributed to Stockholder in redemption of all of the shares of stock presently issued and outstanding in accordance with the Corporation Law of the State of Kansas and pursuant to Sections 332 and 337 of the Internal Revenue Code;

NOW THEREFORE, the parties hereto hereby agree as follows:

1. Stockholder and the Corporation do hereby agree to a complete liquidation pursuant to Sections 332 and 337 of the Internal Revenue Code by which all of the assets of the Corporation will be distributed to Stockholder in redemption of all of the shares of stock presently issued and outstanding to the Stockholder, including all property of the Corporation tangible and intangible subject to all existing debt on the date of distribution to Stockholder in complete cancellation or redemption of all of its issued and outstanding capital stock and such distribution shall be made not later than December 31, 2003.

2. Stockholder hereby authorizes the officers of the Corporation to file a Consent of Stockholder to Dissolution of the Corporation with the Secretary of State of the State of Kansas on or after January 1, 2004.

IN WITNESS WHEREOF, the parties hereto have caused the Agreement and Plan of Liquidation to be executed by their respective duly authorized officers as of the day and year first above written.
