CORRECTIVE TERMINATION AND RELEASE

OF

TRADEMARK SECURITY INTEREST

A TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination and Release"), was executed by Lehman Commercial Paper Inc., as agent (in such capacity, the "Grantee") on August 25, 2005 under that certain Credit Agreement, dated as of June 21, 2000 (as amended, restated, modified or supplemented from time to time prior to the date hereof, (the "Existing Credit Agreement") and was recorded at Reel/Frame No. 2133/0886 on September 9, 2005.

WHEREAS Grantee wishes to correct said Termination and Release of Trademark Security Interest by releasing the Security Interest against TPI Acquisition Subsidiary, Inc.;


WHEREAS Grantee has terminated each Existing Trademark Security Agreement and agreed to release, relinquish and discharge its right, title and interest to the trademark collateral as herein provided;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby agrees as follows:

1. The Grantee hereby releases, relinquishes and discharges in its entirety any and all security interests it has against the trademarks listed in Schedule A.
2. The Grantee hereby agrees, at the expense of the Borrower to take any actions and to execute any further documents necessary or reasonably requested by the Borrower to effectuate, record or evidence the release of the Grantee's Security interest in the trademarks.
3. The Grantee authorizes and requests the United States Patent and Trademark Office to record this Termination and Release against the Trademark Collateral.
4. This Termination and Release shall be governed by the law of the State of New York.
