TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this "Assignment") is made and entered into as of March ~~23~~²⁴, 2009 ("Effective Date") by and between Allan M. Shine, Receiver of The Colibri Group, Inc. ("TCG") and Colibri Corporation ("CC" and, collectively with TCG, the "Seller" or "Assignor") (the "Receiver"), by the authority vested in the Receiver by Order of the Superior Court of the State of Rhode Island, Providence County, entered on the 23rd day of March, 2009, in those consolidated receivership proceedings captioned as Founders Equity SBIC I, L.P. vs. The Colibri Group, Inc., P.B. #09-0253, and Allan M. Shine, Receiver of The Colibri Group, Inc. vs. Colibri Corporation, P.B. #09-0664 (the "Receivership Proceedings") and Ocean State Jobbers, Inc. ("Assignee").

WHEREAS, the books and records of TCG and CC indicate that they own certain trademarks and service marks and they own the trademark and service mark applications and/or registrations and all common law rights associated therewith, which are listed in the Schedule attached hereto and incorporated herein by reference (collectively, the "Marks");

WHEREAS, the Assignor is the subject of the Receivership Proceedings and has agreed to assign all assets, including the Marks, pursuant to the sale process established in the Receivership Proceedings, and to execute this Assignment subject to the Assignee's agreement to, and execution of, the terms and conditions of that Receiver's Bill of Sale executed contemporaneously herewith, the Marks being all or a portion of the Purchased Assets defined in that Receiver's Bill of Sale;


WHEREAS, the Assignor desires to assign all of the rights, title and interests of the Assignor in and to the Marks together with the good will of the business symbolized by the Marks to the Assignee, and the Assignee has agreed to accept said assignment;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns, transfers and sets over to Assignee its entire right, title and interest in and to the Marks together with the good will of the business symbolized by the Marks, including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States or any foreign country, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignors if this Assignment had not been made.

THE TERMS OF THE RECEIVER'S BILL OF SALE ARE HEREBY INCORPORATED BY REFERENCE HEREIN.


