TRADEMARK ASSIGNMENT

The Assignor hereby assigns to the Assignee the entire right, title and interest in and to the trademark applications and registrations listed on Schedule A and the trademarks which are the subjects thereof, including the goodwill of the business connected with the use of, and symbolized by, said marks.
2. The Assignor further agrees, for itself, and its successors and assigns, to execute such further documents and to perform such further lawful acts as may reasonably be requested by the Assignee to effectuate this Trademark Assignment.
