DOES HEREBY CERTIFY:

FIRST: The name and jurisdiction of formation or organization of each of the constituent entities which is to merge are as follows:

THIRD: The name of the surviving Delaware limited liability company is Twain MergerSub L.L.C.

FOURTH: The merger of Caremark Rx, Inc. into Twain MergerSub L.L.C. shall be effective at 3:01 a.m., Eastern Daylight Time, on March 22, 2007 (the "Effective Time").

FIFTH: As of the Effective Time, Article FIRST of the Certificate of Formation of the Surviving Company shall be amended and replaced in its entirety with the following:

"FIRST: The name of the limited liability company is Caremark Rx, L.L.C. (the "Company")."

SIXTH: The executed Agreement and Plan of Merger is on file at a place of business of the surviving Delaware limited liability company. The address of such place of business of the surviving Delaware limited liability company is One CVS Drive, Woonsocket, Rhode Island 02895.


