**UNITED STATES TRADEMARK ASSIGNMENT**



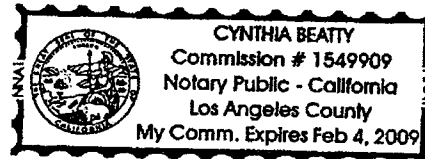


