ASSIGNMENT

THIS ASSIGNMENT is made the 1st day of APRIL 2008/9

BETWEEN

- (1) G. Costa and Company Limited (a corporation organised and existing under the laws of the United Kingdom) of Weston Centre, 10 Grosvenor Street, London, W1K 4QY (hereinafter called "the Assignor")

AND

- (2) AB World Foods Limited (a corporation organised and existing under the laws of the United Kingdom) of Weston Centre, 10 Grosvenor Street, London, W1K 4QY (hereinafter called "the Assignee")

WHEREAS

- (a) The Assignor is the applicant or proprietor and beneficial owner of the trade marks detailed in the Schedule (hereinafter call "the Trade Mark").
- (b) The Assignor has agreed to assign the Trade Marks to the Assignee and to execute this assignment.

In consideration of the sum of £1 paid by the Assignee receipt of which is acknowledged by the Assignor

- (1) THE ASSIGNOR HEREBY ASSIGNS and transfers with full title guarantee to the Assignee

- 1.1 all right title and interest in the Trade Mark
 - 1.2 together with statutory and common law rights and the right to sue for damages and other remedies in respect of any infringement of such rights prior to the first date mentioned above and to retain any damages obtained as a result of such action
 - 1.3 together with the right to apply for prosecute and obtain any further applications for registered trade marks or similar protection or claim priority from the Trade Mark throughout the world in the intent that the resulting grant of any registered trade mark shall be in the name of and vest to the Assignee
- (2) The Assignor confirms that this Assignment is made with the goodwill attaching to the Trade Mark
- (3) The Assignor WARRANTS to the Assignee
- 3.1 that the Assignor has neither entered into any agreement nor appointed any registered user of the Trade Mark nor given any other person any permission to use the Trade Mark
 - 3.2 that the Assignor is unaware of any use by any third party of any mark similar to the Trade Mark in connection with the same or similar goods for which the Assignor has used them and for which Registrations has been made
 - 3.3 that the Assignor is unaware of any infringement of the Trade Mark
 - 3.4 that there are no circumstances known to the Assignor arising out of this or any earlier Assignment which may result in the use of the Trade Mark being liable to mislead the public
 - 3.5 that all previous Assignments of the Trade Mark are valid and that the Assignor is properly entered on to the UK Register of Trade Marks as the proprietor
 - 3.6 that the Assignor has not made any other assignment or purported assignment of the same or similar marks to be used in relation to the same or similar goods to those for which the Registration has been made


- (4) The Assignor further COVENANTS that at the request and cost of the Assignee it will do all such further acts and execute all such documents as may be reasonably necessary or desirable both to secure the proper vesting in the Assignee of all rights assigned to the Assignee and to assist in the resolution of any question concerning the Trade Mark or other rights assigned


