
WHEREAS, Assignor is the owner of the trademarks and service marks listed and described in Schedule A attached hereto and by this reference incorporated herein,



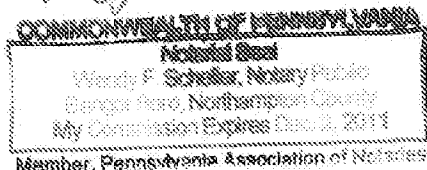

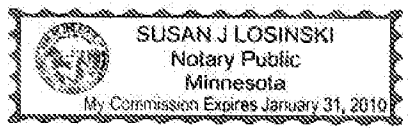
