RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL

This RELEASE, dated as of April 30, 2009, is made by Golub Capital Incorporated ("Golub") in favor of SC Licensing Corp. (the "Borrower").

W I T N E S S E T H:

WHEREAS, Golub was involved in a credit facility pursuant to which credit was extended to the Borrower, and in return the Borrower granted security interests pursuant to the following:

Subordinated Debt Security Agreement dated February 4, 2005 (the "Security Agreement"), by Specialty Catalog Corp., SC Corporation, SC Licensing Corp., SC Publishing Corp. and Royal Advertising & Marketing, Inc. in favor of Golub.

WHEREAS, Golub acknowledges full payment, performance and satisfaction of all obligations secured by the Security Agreement; and

WHEREAS, the Borrower has requested that Golub release its security interest in the collateral described in the Security Agreement (the "Collateral").


