NUNC PRO TUNC ASSIGNMENT OF TRADEMARK

This assignment by **Rhodia, Inc.**, a Delaware corporation with its principle place of business located at 8 Cedar Brook Drive, Cranbury, New Jersey 08512, USA (the "Assignor"), to **Rhodia Operations**, a French société par actions simplifiée with its principle place of business located at 40 rue de la Haie-Coq, Aubervilliers 93306, France (the "Assignee"), hereby states the following:

WHEREAS, Assignor is the owner of the trademark IONQUEST for chemicals used in hydrometallurgy and mineral beneficiation, which is registered in the United States Patent and Trademark Office, Registration No. 1,533,821 issued on April 11, 1989 (the "Mark"), together with the good will of the business symbolized thereby; and

WHEREAS, Assignee is desirous of acquiring the entire rights, title and interest of Assignor in and to the Mark, together with said registration and good will; and
