
WHEREAS, the Secured Party desires to terminate and release the entirety of its security interest in, and lien, on the Trademarks.



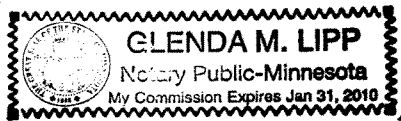
