BILL OF SALE

THIS BILL OF SALE AND ASSIGNMENT AND ASSUMPTION AGREEMENT is executed and delivered on December 31, 2005 (the "Effective Date") by and between PRGRS, Inc., a Delaware corporation ("PRGRS"), and PRGTS, LLC, a Georgia limited liability company ("PRGTS").

PREAMBLES

WHEREAS, on December 16, 2005, the Board of Directors and Sole Stockholder of PRGRS approved the dissolution of PRGRS;

WHEREAS, PRGTS is the Sole Stockholder of PRGRS and entered into an Agreement and Plan of Dissolution dated December 16, 2005 (the "Plan of Dissolution").

NOW, THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged by the execution and delivery hereof, the parties hereto agree as follows:

AGREEMENT

Capitalized terms used and not otherwise defined herein shall have the meaning ascribed to them in the Plan of Dissolution.

FOR GOOD AND VALUABLE CONSIDERATION, RECEIPT OF WHICH IS HEREBY ACKNOWLEDGED, PRGRS hereby sells, assigns, transfers and conveys to PRGTS, its successors and assigns, and PRGTS assumes and accepts from PRGRS subject to all liens, claims and encumbrances of any kind, effective as of the Effective Date, all of PRGRS's and PRGRS's entire right, title and interest in, to and under all of the assets, property, rights and claims of PRGRS, including but not limited to, all registered and unregistered service and trademarks together with the goodwill of the business symbolized by the service and trademarks, including the right to license, and all patent and patent applications, and any foreign counterpart patents and patent applications (collectively, the "Assets"), including but not limited to those Assets set forth on attached Schedule A.

TO HAVE AND TO HOLD the said assets, property, rights and claims unto PRGTS, its successors, transferees and assigns, forever.

No person, firm, corporation or entity other than the parties hereto and the PRGRS shall have any rights or benefits under this Agreement or the provisions contained herein.

Nothing contained herein shall be construed to defeat, impair or limit in any way any rights or remedies of PRGTS to contest or dispute the validity or amount of any liability or obligation specifically assumed by it hereunder.

This Agreement shall be governed by and construed in accordance with the laws of the State of Delaware without regard to the rules of conflict of laws of the State of Delaware or any other jurisdiction.

This Agreement shall be binding upon and inure to the benefit of the parties hereto and their respective affiliates, successors and assigns. This Agreement can be executed in counterparts and by facsimile signatures.
