ARTICLE II. DATE OF FILING OF ARTICLES OF ORGANIZATION

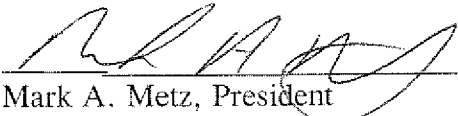
The date the articles of organization of the company were filed in the Office of the Secretary of State of the State of Georgia is January 12, 2000.
