WHEREAS, EFTC Operating Corp., a Delaware corporation having its principal place of business at 2401 West Grandview Road, Phoenix, Arizona 85023 (hereinafter "EFTC") is the record owner of a certain Service Mark registration, namely, U.S. Reg. No. 2,695,146 for SUNTRON in connection with "manufacturing and assembling electronic devices, namely, complex printed circuit boards, cables and electromechanical devices to order and/or specifications of others" (hereinafter the "Mark"); and
