WHEREAS, Assignor is the owner of the trademark/service mark listed on Exhibit "A", attached hereto (the "Intellectual Property");



Assignor further covenants that, when requested, it will, without charge to Assignee, execute all documents and take all such further actions as may be necessary, desirable or convenient to enable Assignee to obtain, maintain and enforce its rights and interest in and to the Trademarks in any and all countries.
