## TRADEMARK ASSIGNMENT

Together with Assignor's right, title and interest in and to the Trademark(s), as well as the goodwill of the business associated with said Trademark(s) being assigned to Assignee, are the rights to police, monitor and enforce said Trademark(s) against any and all past infringements (including, without limitation, the right to sue for and collect damages caused by any such infringement) which may have occurred at any time in the unlimited past, up to the date of this present Assignment, together with any and all further privileges in the United States to establish use, ownership, and/or registration of the Trademark(s).


