**RECITALS**

WHEREAS, the Company and the Secured Party entered into (i) that certain Pledge and Security Agreement, dated as of April 30, 2008, (ii) that certain Trademark Security Agreement dated as of April 30, 2008 (the "2008 Security Agreement"), (iii) that certain Trademark License of the Test Drive Franchise, dated November 8, 2007, and (iv) that certain Trademark Security Agreement dated as November 21, 2007 (the "2007 Security Agreement"), whereby the Secured Party acquired a security interest in certain intellectual property owned by the Company; and

WHEREAS, the Secured Party has agreed to release its security interest in the trademarks listed on Exhibit A hereto.

NOW, THEREFORE, the Secured Party agrees as follows:

The Secured Party expressly terminates its security interest in the trademarks listed on Exhibit A hereto, which security interest was evidenced by the recordation of (i) the 2008 Security Agreement with the United States Patent and Trademark Office on May 1, 2008, in Reel/Frame 3770/0777 and (ii) the 2007 Security Agreement with the United States Patent and Trademark Office on November 21, 2007 in Reel/Frame 3665/0974.
