TRADEMARK ASSIGNMENT

of the Assignee and do all other lawful acts necessary to carry out the intent of this Assignment at the Assignee's expense and request, as well as provide such other material, information, or assistance as the Assignee may consider necessary.

This Assignment shall be binding on the parties, their successors, and/or assigns and all others acting by, through, with, or under their direction, and all those in privity therewith.

The undersigned states that they are authorized to execute this Assignment on behalf of the Assignor; and that they have read, knows and understands the contents thereof, that all statements made herein of their own knowledge are true and all statements made on information and belief are believed to be true; and that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the United States Code.
