**RELEASE**  
**(Trademarks)**

This Release (this "Release"), dated as of May 8, 2009, is executed by BlueBay High Yield Investments (Luxembourg) S.a.r.l (the "Secured Party") in favor of Atari, Inc. (the "Company").

RECITALS

WHEREAS, the Company and Guggenheim Corporate Funding LLP ("Guggenheim") entered into (i) that certain Pledge and Security Agreement dated November 3, 2006 (the "Security Agreement") and (ii) that certain Confirmatory Grant of Security Interest in United States Trademarks dated as of November 3, 2006 (the "Confirmation"), whereby Guggenheim acquired a security interest in certain intellectual property owned by the Company;

WHEREAS, Guggenheim and the Secured Party entered into that certain Resignation and Appointment agreement, dated October 23, 2007, whereby, among other things, the Secured Party, its successors, legal representatives, and assigns, acquired all liens and security interests granted to Guggenheim by the Company under the Security Agreement; and

WHEREAS, the Secured Party has agreed to release its security interest in the trademarks listed on Exhibit A hereto.

NOW, THEREFORE, the Secured Party agrees as follows:

The Secured Party expressly terminates its security interest in the trademarks listed on Exhibit A hereto, which security interest was evidenced by the recordation of (i) the Confirmation with the United States Patent and Trademark Office on November 11, 2006, at Reel/Frame 3422/0480, and (ii) the Notice of Assignment of United States Trademarks with the United States Patent and Trademark Office on November 16, 2007, at Reel/Frame 3663/0794.
