
Please be advised that pursuant to (a) an **AMENDED AND RESTATED NOTE PURCHASE AND REVOLVING CREDIT AGREEMENT**, dated as of December 6, 2008 (as may be further amended, restated, supplemented or otherwise modified from time to time, the "**Note Agreement**"), by and among Gene Juarez Salons LLC, a Delaware limited liability company formed pursuant to a Reorganization described in the Note Agreement (the "**Company**"), Gene Juarez Beauty Schools LLC, a Delaware limited liability company known as "Gene Juarez Salons LLC" prior to the consummation of such Reorganization ("**GJ Beauty Schools**"), GJS Holdings LLC, a Delaware limited liability company ("**Holdings**"), the Purchasers of the Notes named therein, and the Prudential Insurance Company of America, in its capacity as collateral agent for the holders from time to time of the Notes (together with its successors and assigns in such capacity, the "**Collateral Agent**"), and (b) the related **AMENDED AND RESTATED SECURITY AGREEMENT**, dated as of December 6, 2008 (as may be further amended, restated, supplemented or otherwise modified from time to time, the "**Security Agreement**"), made by the Company, GJ Beauty Schools, Holdings and each of the other affiliates and subsidiaries of Holdings identified as "Grantors" therein in favor of the Collateral Agent, the undersigned Company (hereinafter, the "**Grantor**") has granted a continuing security interest in and continuing lien upon the trademarks, trademark applications, patents, patent applications, copyrights and copyright applications, each of which is described on Schedule I attached hereto, in favor of the Collateral Agent. Capitalized terms used herein and not otherwise defined have the meanings assigned to such terms in the Note Agreement, and if not defined therein, as defined in the Security Agreement.

The undersigned Grantor hereby acknowledge and agree that the security interest in the foregoing intellectual property (i) may only be terminated in accordance with the terms of the Note Agreement and the Security Agreement and (ii) is not to be construed as an assignment of any intellectual property.
