The undersigned, being hereby warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements may jeopardize the validity of the application or document or any registration resulting there from, declares that:


1. I am properly authorized to execute this Declaration on behalf of Registrant.
2. The assignment document recorded at Reel No. 2150, Frame No. 0317 contained erroneous information in that it should not have included the present registration. The assignment document in question recorded a security interest from Specialty Retailers, Inc. to Citicorp USA, Inc. Specialty Retailers, Inc. is not now nor has it ever been the rightful owner of U.S. Trademark Registration No. 2,616,142.
3. Pursuant to TMEP § 503.06(c), Registrant made an attempt to contact the party that recorded the erroneous assignment papers to have that party file corrective papers. However, such attempts were unsuccessful. Accordingly, Registrant is taking the necessary steps on its own to correct the assignment record.

4. The true chain of title for this registration is as follows: registration issued to Copper Mountain, Inc. on September 10, 2002; on December 30, 2008, a security interest from Copper Mountain, Inc. to JPMorgan Chase Bank, N.A. was recorded at Reel No. 3910, Frame No. 0463. As Specialty Retailers, Inc. was never the proper owner, U.S. Trademark Registration No. 2,616,142 is not encumbered by any security or other interest owned by Citicorp USA, Inc. Accordingly, the original registrant has been and continues to be the owner of the registration subject only to the above-referenced security interest owned by JPMorgan Chase Bank, N.A.

5. All statements made of my own knowledge are true; and all statements made on information and belief are believed to be true.
