The parties agree that, as majority (but not sole) owner of Assignor, Assignee shall at all times maintain control over the nature and quality of the goods sold under the

Trademark such that use of the mark by Assignor inures to the Applicant's benefit. Assignee shall have the right to exercise control over the nature and quality of the goods sold under the Trademark, and shall exercise such right, by personally approving, in advance, (1) all products of Assignor, or changes to such products, to which the Trademarks are applied, (2) all manufacturing methods, or changes to such methods, used by Assignor to produce such products, and (3) all written or printed materials intended for circulation to customers or potential customers for such products that contain reference to the Trademarks. Assignor and Assignee agree to cooperate to facilitate Assignee's personal review and approval of the above-listed matters.
