## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of April 23, 2009, by Wilmington Savings Fund Society, FSB ("Wilmington").

WITNESSETH:

WHEREAS, Wilmington and LNH, Inc., a Delaware corporation ("LNH"), were parties to a Commercial Security Agreement dated as of March 24, 2008 (the "Assignment"), pursuant to which LNH granted a security interest to Wilmington in certain trademarks (the "Trademarks") and Trademark Rights (as defined below) as security for certain obligations owing by LNH to Wilmington, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Assignment was recorded by the Trademark Division of the United States Patent and Trademark Office on March 25, 2008, at Reel 3746, Frame 0089; and

WHEREAS, LNH has requested that Wilmington release its security interest in the Trademarks and Trademark Rights and reassign the same to LNH.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Wilmington hereby releases its security interest in all of LNH's right, title and interest in and to the following (collectively the "Trademark Rights"):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and


(ii) all products and proceeds of the foregoing, including without limitation, any claim by LNH against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Wilmington hereby reassigns grants and conveys to LNH, without any representation, recourse or undertaking by Wilmington, all of Wilmington's right, title and interest in and to the Trademarks and the Trademark Rights.
