DECLARATION

I, Maurice Bowen, declare that:

1. I am Vice President - Marketing of Tracker Marine, L.L.C. I make this declaration in support of our Request to Correct the Owner of Service Mark Registration No. 1,556,220 as recorded with the Assignment Service Branch of the U.S. Patent and Trademark Office.

2. Tracker Marine, L.L.C., is, by assignment at reel/frame 2167/0276, the true owner of Service Mark Registration No. 1,556,220, and has discovered, as a result of a post-registration office action issued on February 23, 2009 by the Trademark Specialist in the Post Registration Division who examined the renewal application for Service Mark Registration No. 1,556,220, that Bank of America, N.A. improperly recorded an assignment and name change against its registration. The Trademark Specialist is requesting that Tracker Marine, L.L.C. establish ownership of the registration.

3. Tracker Marine, L.L.C.'s representatives contacted Bank of America, N.A. and asked them to record corrective papers. To date, the corrective papers have still not properly changed ownership of the registration back to Tracker Marine, L.L.C. Therefore, the true owner, Tracker Marine, L.L.C., is recording this declaration with the Assignment Services Branch to correct the error and to be able to file a timely response to the outstanding post-registration office action.


4. To the best of our knowledge, following is our understanding of the chain of events that leads to the misidentified owner of the registration:

Bank of America, N.A. filed a Security Agreement which is recorded at reel/frame 3267/0043. However, Bank of America, N.A., in an attempt to update a certain assignor name in the recorded Security Agreement to read: "BASS PRO INTELLECTUAL PROPERTY, L.L.C Formerly: FORMERLY BASS PRO TRADEMARKS, L.L.C.", filed a subsequent corrective assignment which was recorded at reel/frame 3747/0001. However, because of the language Bank of

America, N.A. listed in the conveyance portion of the cover sheet, namely, *"Corrective Assignment to Correct the Nature of Conveyance Previously Recorded on Reel 3267 Frame 0043. Assignor(s) Hereby Confirms The Amended and Restated Security Agreement"*, the Assignment Division recorded that as a true assignment which placed the registration in the name of Bank of America, N.A. At the request of representatives of Tracker Marine, L.L.C., Bank of America contacted the Assignment Division in an attempt to correct the erroneous filing over the telephone. The resulting conveyance type now appears as "Change of Name" at reel/frame 3747/0001. Bank of America, N.A. made yet another attempt to correct the assignment conveyance type to read *"Nature Of Conveyance: Corrective Document To Correct The Nature Of Conveyance Recorded At Reel 003747 Frame 0001. Delete "Change Of Name" And Amend To Amend To--Other-Amended Articles Of Organization"* at reel/frame 3936/0250. Unfortunately, these attempts to correct the owner information have failed and the registration still erroneously remains in the name of Bank of America, N.A., when in fact this should appear as a Security Agreement only.

5. The owner, Tracker Marine, L.L.C., has to the best of its knowledge provided a summary of events leading to the misidentified owner. The registration identified should not be considered altered by the incorrect assignment and name change. Further, Tracker Marine, L.L.C. has been and continues to be the true owner of the registration at issue.

I declare under penalty of perjury that to the best of my knowledge the foregoing is true and correct.
