**ARTICLE II:**

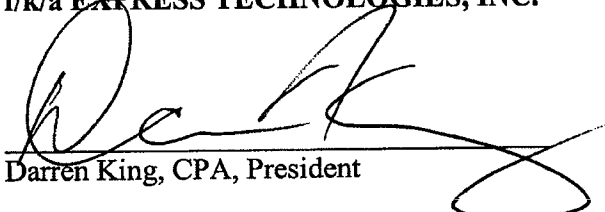
The effective date of the foregoing amendment shall be the date of filing of these Articles of Amendment with the Kentucky Secretary of State.
