CONTINUATION OF SECURITY INTEREST

Ladies and Gentlemen,

Reference is made to (a) that certain First Lien Credit Agreement dated as of June 14, 2007 (as amended, restated or otherwise modified from time to time, the "First Lien Credit Agreement"), by and among Edgestone CD Acquisition Corp., a Delaware corporation, (the "Company"), Custom Direct, Inc., a Delaware corporation ("CDI"), and Custom Direct LLC, a Delaware limited liability company ("Custom Direct LLC" and, together with the Company and CDI, the "Borrowers" and each a "Borrower"), the Subsidiary Guarantors party thereto (together with the Borrowers, the "Obligors"), the lenders party thereto, and BNP Paribas, as administrative agent (the "First Lien Administrative Agent") and (b) that certain Second Lien Credit Agreement dated as of June 14, 2007 (as amended, restated or otherwise modified from time to time, the "Second Lien Credit Agreement"), by and among the Obligors, the lenders party thereto, and BNP Paribas, as second lien administrative agent (the "Second Lien Administrative Agent"). Capitalized terms used herein but not defined herein shall have the meaning given to such term in the First Lien Credit Agreement and the Second Lien Credit Agreement as applicable.

Reference is also made to (a) that certain First Lien Intellectual Property Security Agreement dated as of June 14, 2007 (as amended, restated or otherwise modified from time to time, the "First Lien IP Agreement"), by and among the Borrowers, the other Grantors party thereto, and the First Lien Administrative Agent and (b) that certain Second Lien Intellectual Property Security Agreement dated as of June 14, 2007 (as amended, restated or otherwise modified from time to time, the "Second Lien IP Agreement"), by and among the Borrowers, the other Grantors party thereto, and the Second Lien Administrative Agent.

Reference is further made to the following transfers of the intellectual property listed on Exhibit A hereto (the "Transferred Intellectual Property") on or prior to the date hereof:

1. the distribution of the Transferred Intellectual Property (other than the patent applications set forth on Exhibit A hereto) by Custom Direct LLC to CDI;
3. the contribution of the Transferred Intellectual Property by CDI to EZShield Holdings LLC ("EZShield Holdings"); and
4. the contribution of the Transferred Intellectual Property by EZShield Holdings to EZShield, Inc. ("EZShield, Inc.").

Each of Custom Direct LLC, CDI, EZShield Holdings and EZShield, Inc. hereby agree and provide notice that—

(a) the Transferred Intellectual Property remains subject to all liens, security interests, mortgages and other encumbrances (collectively, the "Security Interests") granted by

Custom Direct LLC in favor of the First Lien Administrative Agent and the Second Lien Administrative Agent and that were in effect immediately prior to the transfers of the Transferred Intellectual Property described herein;


(b) the Transferred Intellectual Property will continue to remain subject to the Security Interests until such Security Interests are released in accordance with the terms of the Loan Documents; and

(c) following the occurrence of an Event of Default (as defined in either of the First Lien Credit Agreement or the Second Lien Credit Agreement), the First Lien Administrative Agent and the Second Lien Administrative Agent will have all of the rights and remedies with respect to the Transferred Intellectual Property that are provided for by the First Lien Credit Agreement, the Second Lien Credit Agreement, the First Lien IP Agreement and the Second Lien IP Agreement.






