TERMINATION AND RELEASE OF SECURITY INTEREST

THIS TERMINATION AND RELEASE OF SECURITY INTEREST (hereinafter referred to as the "Release") is made as of the 15th day of May, 2009 by Wachovia Capital Finance Corporation (Central), formerly known as Congress Financial Corporation (Central), having a place of business at 150 South Wacker Dr., Suite 2200, Chicago, IL 60606 ("Releaser"), in favor of Wilkinson Industries, Inc., a Delaware corporation and successor in interest to Wilkinson Manufacturing Company ("Releasee").

RECITALS

Pursuant to a security interest agreement (mortgage) dated August 20, 1991 (the "Security Agreement"), Releasee is the grantee of record of a certain security interest in U.S. trademarks identified on the attached Schedule 1 (the "Trademarks"), which was granted to Releaser by Releasee and recorded at the United States Patent and Trademark Office at reel/frame number 1003/0085.

Wilkinson Manufacturing Company merged with and into Wilkinson Industries, Inc. on December 31, 2004.

Congress Financial Corporation (Central) changed its name to Wachovia Capital Finance Corporation (Central).

Releasee has paid and performed in full its obligations to Releaser and terminated all further obligations of Releaser to extend credit to Releasee. Releaser desires by execution of this Release to terminate and release the entirety of its security interest in, and lien on, the Trademarks.


RELEASE

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Releaser does hereby release and terminate its security interest in, and lien on, the Trademarks, does hereby request that the United States Patent and Trademark Office so amend the respective record of each of the Trademarks set forth on the attached Schedule I and does hereby assign and transfer to Releasee, without recourse, Releaser's entire rights, title, and interest in and to the Trademarks, which were pledged in the Security Agreement, effective as of the date set forth above.
