## **RELEASE OF SECURITY INTEREST**

WHEREAS, the Secured Party was previously granted a security interest in and to certain intellectual property assets listed in the Schedules attached hereto (the "Intellectual Property Assets") pursuant to that certain Intellectual Property Security Agreement dated as of December 9, 2004 by EasyLink in favor of the Secured Party (the "IP Security Agreement"); and

WHEREAS, all obligations of EasyLink and its affiliates under the Credit Agreement (as such term is defined in the IP Security Agreement) have been satisfied in full; and

WHEREAS, the Secured Party now desires to release any and all security interests in the Intellectual Property Assets granted by EasyLink and its affiliates to Secured Party pursuant to the IP Security Agreement and the other documents entered into in connection with the Credit Agreement; and


NOW, THEREFORE, for and in consideration of the premises and mutual promises in the IP Security Agreement and herein contained, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party and EasyLink agree as follows:

1. The Secured Party hereby releases any and all security interests in and to the Intellectual Property Assets.
2. The IP Security Agreement is hereby terminated in accordance with Section 8 thereto except those provisions of the IP Security Agreement which expressly survive termination thereof shall survive such termination.
3. This Release shall be governed by the laws of the State of New York, without regard to choice of law or conflicts of law principles.
4. This Release and may be signed in any number of counterparts, each of which shall be deemed an original.
