TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (“Agreement”) is made effective as of January 22, 2009 (the “Effective Date”), by and between **DISCOVERY TOYS, INC.**, a California corporation (the “Assignor”), and **DISCOVERY TOYS LLC**, a Delaware limited liability company (the “Assignee”).

WHEREAS, the Assignor is the owner of all right, title and interest in and to the U.S. Registrations set forth on Exhibit 1 hereto (collectively, the “Trademarks”), and the goodwill associated with the Trademarks (the “Goodwill”), subject to the liens set forth on Exhibit 1 (collectively, the “Permitted Liens”;

WHEREAS, the Assignee is desirous of acquiring all rights, title and interest in and to the Trademarks and Goodwill, subject to the Permitted Liens.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. The Assignor hereby assigns, transfers, and conveys to the Assignee, the entire right, title, and interest in and to the Trademarks and the Goodwill, subject to the Permitted Liens, to be held and enjoyed by the Assignee, its successors, assigns and other legal representatives, as fully and completely as the same would have been held by Assignor if this assignment had not been made. Without limiting the generality of the foregoing, the Assignor hereby assigns, transfers, and conveys unto the Assignee causes of action and rights to bring suit for infringement of the Trademark.
2. The Assignor hereby authorizes and requests any official throughout the world whose duty it is to register and record ownership in intellectual property rights, including the United States Patent and Trademark Office, to record the Assignee as the assignee and owner of the Trademarks, subject to the Permitted Liens.
3. The Assignor hereby agrees to execute and deliver at a future date any additional documents that the Assignee determines may be necessary or desirable, or that may be required under federal or state law, to preserve and protect, and to perfect the Assignee’s ownership of, the Trademarks and Goodwill. The Assignor hereby grants to the Assignee a Power of Attorney (which power is hereby acknowledged to be coupled with an interest and irrevocable) and appoints the Assignee to serve as its agent

and Attorney-in-fact, with powers of substitution, in each case for the limited purposes of executing and delivering such documents and doing such acts in the Assignor's place and stead as the Assignor would otherwise be obligated.

4. This Agreement shall be governed by, and construed in accordance with, the laws of the State of California, without regard to any conflict of laws provisions.
