ARTICLES OF ORGANIZATION

OF

ARTICLE I.

1.01 The name of the *Company* is Conservice, LLC.

ARTICLES OF ORGANIZATION

OF

Zip Reports, LLC

We, the undersigned natural persons acting as Members of this Utah limited liability company (hereinafter "*Company*") under the Utah Limited Liability Company Act, adopt the following Articles of Organization for such *Company*.

ARTICLE I.

1.01 The name of the *Company* is Zip Reports, LLC.

ARTICLE II.

2.01 The period of this *Company's* duration is forty (40) years, beginning on the date of filing this Articles of Organization.

ARTICLE III.

PURPOSES

3.01 The business purpose and object for which this *Company* is organized shall be to conduct any or all lawful business for which limited liability companies may be organized, including, but not limited to, the following:

(a) To provide various internet related services including high-speed systems, consulting, web page design and credit report applications.

(b) To do each and every thing necessary, suitable, or proper for the accomplishment of any of the purposes or the attainment of any one or more of the objects herein enumerated, or which may at any time appear conducive to or expedient for the protection or benefit of this *Company*, and to do said acts as fully and to the same extent as natural persons might, or could do, in any part of the world as principals, agents, partners, trustees, or otherwise, either along or in conjunction with any other person, partnership (whether limited or general and whether as limited or general partners), association, joint venture, or corporation.

The foregoing paragraphs shall be construed both as objects and powers and shall not be held to limit or restrict in any manner the general powers of the Company and the enjoyment and exercise thereof, as conferred by the laws of the State of Utah; and it is intended that the purposes, objects, and powers specified in each of the paragraphs of this Article III, Company purposes, of these Articles or Organization shall be regarded as independent purposes, objects, and powers.

ARTICLE IV.

REGISTERED OFFICE AND AGENT

The name of the *Company's* initial registered agent and the street address of the *Company's* initial registered office are as follows:

ARTICLE V.

MANAGEMENT AND MEMBERS

5.01 The *Company* will be managed by a manager or managers, as provided in an Operating Agreement to be executed by the Members. The initial manager shall be the following, who shall serve as manager until the first meeting of Members or until their successors are elected and qualified. ARTICLE VI.

LIABILITY OF MEMBERS

6.01 The Members of the *Company* shall not be liable for any of the debts or obligations of the *Company*.

ARTICLE VII.

AMENDMENT

7.01 These Articles of Organization maybe amended by the affirmative vote of the Members holding a majority of the distributive shares of the *Company* at a meeting of the Members called for that purpose upon giving of not more than thirty (30) days nor less than two (2) days notice to all such Members of record; provided, however, that such a meeting may be

called without notice when notice is waived in writing by all Members of the *Company*.

ARTICLE VIII.

MEMBERS' CONTRACTS

8.01 No contracts or other transactions between the *Company* and any other entity shall in any way be affected or invalidated by the fact that any of the Members of the *Company* are pecuniary or otherwise interested in, or are Members', trustees, partners, directors or officers of such other entity.


Any Member individually, or any entity with which any member may be associated, may be a party to or may be pecuniary or otherwise interested in, any contracts or transactions of the *Company*, provided that the fact that such Member or such trust, organization or corporation is so interested shall be disclosed to or shall have been known by the Members or a majority thereof.

ARTICLE IX.

OPERATING AGREEMENT

The Members of the *Company* shall have the right to enter into an Operating Agreement to regulate and manage the affairs of the *Company* in any manner not inconsistent with law or these Articles. The power to adopt, alter, amend or repeal the Operating Agreement shall be vested in the Members.

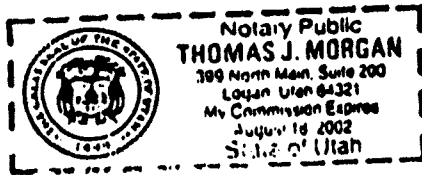
