## TRADEMARK ASSIGNMENT AGREEMENT

THIS AGREEMENT, effective on May 26, 2009, is between The Bypass Trust U/W of S.P. Finger, a trust created and governed by the laws of the State of Texas, the Generation-Skipping Marital Deduction Trust U/W of S.P. Finger, a trust created and governed by the laws of the State of Texas, The Residuary marital Deduction Trust U/W of S.P. finger, a trust created and governed by the laws of the State of Texas, and Florence S. Finger (hereinafter collectively "Assignors"), and Buff Park Property LLC, a Texas Limited Liability Company ("BPP"), having its principal place of business at 4001 Gulf Freeway, Houston, Texas 77005.

WHEREAS, Assignors acquired all right, title, and interest in the trademarks and service marks referenced in Appendix A hereto (the "Marks"), together with the goodwill of the business symbolized thereby, and other assets related to that business on March 13, 2009;

WHEREAS, Assignors are collectively the owners of a 100% interest in BPP, the holdings of which include certain assets previously associated with the business symbolized by the Marks;

WHEREAS, Assignors are desirous of continuing the business symbolized by the Marks and believes assigning the Marks to BPP furthers that objective;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto, intending to be legally bound, agree as follows:


Assignors hereby assign, transfer, and convey to BPP all right, title, and interest in and to the Marks, together with the goodwill of the business symbolized thereby, and the right to recover damages and profits for past infringement thereof.

In the event at any time after the effective date hereof any further action is necessary to record this Agreement, to record the assignment of the Marks in their respective trademark offices in the name of BPP, or to validate the assignment of the Marks, Assignors shall execute the appropriate document at the request of BPP and at the sole expense of BPP.

This Agreement shall be governed by and construed in accordance with the laws of the United States of America and of the State of Texas.

IN WITNESS WHEREOF, the parties have caused this Agreement to be executed on the date first above written, by and through their duly authorized agents.


