
WHEREAS, Assignor desires to assign all rights, title, and interest in and to the Trademark (as defined below) to Assignee;

Assignor further covenants and agrees that it and its representatives will, at Assignee's request and expense, do all other lawful acts necessary to enable Assignee to obtain, maintain and enforce full the benefits of the rights and interests herein sold, assigned, transferred, and conveyed. Assignor represents and warrants that it owns all right, title, and interest in and to the Trademark and that it has the authority to transfer all of the rights sold, assigned, transferred, and conveyed pursuant to this Agreement. This Assignment is effective as of May 21, 2009. The undersigned hereby represent and warrant that they have the authority to execute this Agreement behalf of their respect entities.


