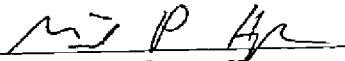
2. The Certificate of Incorporation is hereby amended by striking out Article First thereof and by substituting in lieu thereof a new Article First which shall read in its entirety as follows:
