GRANT OF SECURITY INTEREST

WHEREAS, INVESTORPLACE MEDIA, LLC (formerly known as ACP PHILLIPS INVESTMENT RESOURCES, LLC), a Delaware limited liability company (“InvestorPlace”) owns all right, title and interest in and to the trademarks described on Schedule A (the “Trademarks”) (capitalized terms used and not defined herein have the meanings given to them in the Agreement (defined below));

WHEREAS, InvestorPlace is a party to a Security Agreement dated January 31, 2007 (as the same may be amended, restated, modified, supplemented and/or replaced from time to time, the “Agreement”) in favor of NATIONAL CITY BANK as Administrative Agent for itself and other Secured Parties referred to in the Agreement (in such capacity, with its successors and assigns hereinafter referred to as “Agent”); and

WHEREAS, pursuant to the Agreement, InvestorPlace granted to Agent (for the benefit of the Secured Parties) a security interest in all right, title and interest of InvestorPlace in and to, among other things, the Trademarks, together with the goodwill of the business symbolized by the Trademarks, and any and all applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all past, present and future causes of action which may exist by reason of infringement thereof (the “Collateral”), to secure the payment, performance and observance of the Secured Obligations, as defined in the Agreement;


NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, InvestorPlace does hereby grant to Agent a security interest in the Collateral, effective as of the date InvestorPlace first obtained rights in the Collateral, to secure the prompt payment, performance and observance of its obligations.

InvestorPlace does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the security interest in the Collateral made and granted hereby are fully set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.


