PATENT AND TRADEMARK RELEASE OF SECURITY INTEREST

THIS PATENT AND TRADEMARK RELEASE OF SECURITY INTEREST (this "Release") is made as of May 28, 2009 by JPMORGAN CHASE BANK, N.A., as Collateral Agent (the "Collateral Agent").

WITNESSETH:

WHEREAS, the Collateral Agent and SHPS Holdings, Inc., a a Delaware corporation ("Holdings"), SHPS, INC., a Florida corporation ("Borrower"), SHPS HUMAN RESOURCE SOLUTIONS, INC. (formerly known as EBenX, Inc. and Arbor Associates, Inc.), a Kentucky corporation ("SHPS Human Resource"), SHPS HEALTH MANAGEMENT SOLUTIONS, INC. (formerly known as CareWise, Inc.), a Delaware corporation ("SHPS Health Management"), and OMS Incorporated, a Massachusetts corporation ("OMS", collectively along with Holdings, Borrower, SHPS Human Resource and SHPS Health Management the "Grantors"), were parties to that certain Guarantee and Collateral Agreement, dated as of February 5, 2003 (as amended, restated, supplemented, or otherwise modified from time to time, the "Security Agreement"; capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed thereto in the Security Agreement), pursuant to which Grantors granted a security interest to the Collateral Agent, for the benefit of the Secured Parties, in the Released Patents and Trademarks (as defined below), as security for the Obligations owing by the Grantors to the Secured Parties;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office, Patent Division, on February 19, 2003 at Reel 013751, Frame 0160;

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office, Trademark Division, on (i) February 19, 2003 at Reel 002672, Frame 0530, (ii) June 1, 2004, at Reel 002978 and Frame 0631, (iii) June 1, 2004, at Reel 002863 and Frame 0195 and (iv) June 1, 2004, at Reel 002978 and Frame 0605; and

WHEREAS, the Obligations have now been satisfied and the Grantors have requested that the Collateral Agent release its security interest in the Released Patents and Trademarks and reassign the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Collateral Agent hereby terminates and releases its security interest in all of the Grantors' right, title and interest in and to all of the following (collectively, the "Released Patents and Trademarks"):

- (a) all letters patent of the United States or any other country, all registrations and recording thereof, and all applications for letters patent of the United States or any other country, including registrations, recordings and pending applications in the United States Patent and Trademark Office or any similar offices in any other country, including those listed on Schedule I attached hereto (the "Patents");
- (b) all reissues, continuations, divisions, continuations-in-part, renewals or extensions of the Patents, and the inventions disclosed or claimed in the Patents, including the right to make, use and/or sell the inventions disclosed or claimed in the Patents;
- (c) all trademarks, service marks, trade names, corporate names, company names, business names, fictitious business names, trade styles, trade dress, logos, other source or business identifiers, designs and general intangibles of like nature, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all registration and recording applications filed in connection therewith, including registrations and registration applications in the United States Patent and Trademark Office or any similar offices in any State of the United States or any other country or any political subdivision thereof, and all extensions or renewals thereof, including those listed on Schedule I attached hereto (the "Trademarks");
 - (d) all goodwill associated with or symbolized by the Trademarks; and
- (e) all other assets, rights and interests that uniquely reflect or embody such goodwill.
- 2. The Collateral Agent hereby reassigns to the Grantors, without any representation, warranty, recourse or undertaking by Collateral Agent, all of the Collateral Agent's right, title and interest in and to the Released Patents and Trademarks.
- 3. The Collateral Agent agrees to execute, acknowledge, procure and deliver any further appropriate documents as may be reasonably requested by the Grantors to evidence the Release, in each case at the Grantors' expense without recourse to or representation or warranty by the Collateral Agent.
- 4. Any release, termination or reassignment pursuant to the terms of this Release, and the execution and delivery of the Release are made without recourse to or representation or warranty by the Collateral Agent.
