

Assignor hereby further authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademarks, to record this Assignment, and to issue or transfer all rights, title, and interest in and to the Mark to the Assignee as owner of full and exclusive right, title and interest in and to the Mark, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.
