NUNC PRO TUNC TRADEMARK ASSIGNMENT

A. ARINC Control And Information Systems, LLC, a Delaware limited liability company, with an address at 2551 Riva Road, Annapolis, Maryland 21401 (“Assignor”) was the owner of all right, title and interest in the following trademarks and corresponding trademark registration:

- AIM and U.S. Registration No. 2,301,647 – AIM for “computer software for the control and monitoring of complex industrial systems, namely, transit authorities, nuclear sites and power generation/distribution applications” and “training materials, namely, printed instructional materials books and manuals related to computer software for the control and monitoring of complex industrial systems in the field of public transit, nuclear sites and power general facilities,” issued December 21, 1999.

B. On January 1, 2009, Assignor assigned and conveyed to ARINC Incorporated, a Delaware corporation with an address at 2551 Riva Road, Annapolis, Maryland 21401 (“Assignee”), all right, title and interest in and to the above-identified trademark and the corresponding trademark registration, together with the goodwill of the business symbolized by said trademark and by the trademark registration thereof.

C. The parties are desirous of confirming and ratifying said assignment.

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby assign and convey unto Assignee, nunc pro tunc, as of January 1, 2009, all right, title and interest in said trademark and the corresponding trademark registration, together with the goodwill of the business symbolized by said trademarks and by the trademark registration.


Assignor further assigns unto Assignee all right to sue for and receive all past damages accruing from past infringement of the trademark and the trademark registration assigned herein.
