RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “Release”) is made this 26th day of May, 2009, by L&P FINANCIAL SERVICES, CO., a Delaware corporation, with an office located at No. 1 Leggett Road, Carthage, Missouri 64836 (“Secured Party”).

WHEREAS, reference is made to a certain Second Amended and Restated Collateral Assignment of Intellectual Property Security Agreement dated June 25, 2007 (as amended, restated supplemented and/or modified to date, the “Intellectual Property Security Agreement”), by and among CONSOLIDATED BEDDING, INC. (“Holdings”), NATURE’S REST MARKETING, L.L.C. (“NRM”), NATURE’S REST, INC. (“NRI”), AMERICAN BEDDING INDUSTRIES, INC. (“ABI”), THE SPRING AIR COMPANY, SUCCESSOR BY MERGER TO TSAC MERGER SUB, INC. (“TSAC”), SPRING AIR PARTNERS – NORTH AMERICA, INC. (“SAPNA”), SPRING AIR PARTNERS – NEW JERSEY (“SAPNJ”), SPRING AIR PARTNERS – CALIFORNIA, INC. (“SAPCA”), CHATTAM & WELLS, INC. (“C&W”), SPRING AIR CALIFORNIA-DELUXE BEDDING CO., INC. (“Deluxe”), ACKERMAN MANUFACTURING COMPANY (“Ackerman”), SPRING AIR MATTRESS COMPANY OF COLORADO (“SAMCC”), SPRING AIR – MOUNTAIN WEST, L.L.C. (“SAMW”), SPRING AIR WEST, L.L.C. (“SAW”), SPRING AIR MATTRESS COMPANY (“SAMC”), SPRING AIR BEDDING COMPANY (“SABC”), ATLAS BEDDING MANUFACTURING CORPORATION (“Atlas”), ASSOCIATED TRUCKING COMPANY, INC. (“Trucking”), SPRING AIR PARTNERS – TEXAS, INC. (“SAPTX”) and ALABAMA BEDDING MFG. CO., INC. (“Alabama”, and together with Holdings, NRM, NRI, ABI, TSAC, SAPNA, SAPNJ, SAPCA, C&W, Deluxe, Ackerman, SAMCC, SAMW, SAW, SAMC, SABC, Atlas, Trucking and SAPTX collectively, the “Grantors”) and Secured Party. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Intellectual Property Security Agreement.

WHEREAS, in connection with the Intellectual Property Security Agreement, the Grantors granted Secured Party, a continuing security interest in all of the right, title and interest of Grantors in and to (i) the patent collateral identified therein (collectively, the “Patent Collateral”); (ii) the trademark collateral identified therein (the collectively, “Trademark Collateral”); (iii) the copyright collateral identified therein (the collectively, “Copyright Collateral”); and (iv) the domain name collateral identified therein (the collectively, “Domain Name Collateral”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby irrevocably releases and terminates all its security interest in and to (i) the Patent Collateral, including without limitation, the Patents described in the schedules attached to the Intellectual Property Security Agreement and attached as Schedule I hereto; (ii) the Trademark Collateral, including without limitation, the Trademarks described in the schedules attached to the Intellectual Property Security Agreement and attached as Schedule II hereto; (iii) the Copyright Collateral, including without limitation, the Copyrights described in the schedules attached to the Intellectual Property Security Agreement and attached as Schedule III hereto; and (iv) the Domain Name Collateral, including without limitation, the Domain Names described in the schedules attached to the Intellectual Property Security Agreement and attached as Schedule IV hereto.

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.
