**RELEASE OF TRADEMARK SECURITY INTEREST**

1 This RELEASE OF TRADEMARK SECURITY INTEREST (this "Release") is made as of June 2009, by Bank of America, N.A., as administrative agent (the "Agent"), for the Secured Parties referred to in the Security Agreement (defined below).

**WITNESSETH:**

WHEREAS, reference is made to that certain: (i) Credit Agreement dated as of May 16, 2007 by and among Graphic Packaging International, Inc. ("Borrower"), the several Lenders from time to time parties thereto, and Agent (as in force on the date hereof, the "Credit Agreement"; capitalized terms used and not defined herein shall have the meanings given to such terms in the Credit Agreement) and (ii) Guarantee and Collateral Agreement dated as of May 16, 2007 (as in force on the date hereof, the "Security Agreement") made by Borrower, Graphic Packaging Corporation and certain subsidiaries of the Borrower party thereto in favor of Agent for the benefit of the Secured Parties (as defined in the Security Agreement);

WHEREAS, pursuant to that certain Assumption Agreement dated March 10, 2008, Bluegrass Container Holding, LLC ("BCH") agreed to become a party to the Security Agreement and granted to the Agent a security interest in the Trademarks (as defined below);

WHEREAS, in connection with the Security Agreement, BCH and Agent were parties to that certain Notice and Confirmation of Grant of Security Interest in Trademarks, dated March 10, 2008 (the "Agreement"), pursuant to which BCH granted to Agent, a security interest in certain U.S. trademarks, trademark registrations and trademark applications as more particularly set forth on Schedule A attached hereto (the "Trademarks") to secure the Obligations (as defined in the Security Agreement); and

WHEREAS, the security interest in the Trademarks was recorded with the Assignment Division of the United States Patent and Trademark Office on March 17, 2008 at Reel 3747, Frame 0889.

NOW THEREFORE, in consideration for the premises and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in the Trademarks originally granted to Agent pursuant to the Agreement.
2. Agent hereby assigns, grants and otherwise re-conveys to BCH, all of its right, title and interest in and to the Trademarks and all goodwill associated therewith originally granted to Agent pursuant to the Agreement.
3. Upon the request of BCH, Agent further agrees to execute all documents necessary to demonstrate and confirm the parties' intent under this Release.
