**TRADEMARK ASSIGNMENT**

WHEREAS, TAGA Medical Technologies, Inc., an Ohio corporation, has adopted, used, and is using the mark VELOCITY in its business and which is registered in the United States Patent and Trademark Office as U.S. Registration No. 2,660,525 (the "Mark"); and

2. Assignor further covenants and agrees that it will, at any time upon request, execute and deliver any and all documents that may be necessary or desirable to perfect Assignee's rights in and to the Mark; and
3. This Assignment includes any and all rights to, use for and recovery of all damages for infringement of the Mark, past and future, and the causes of action therefore. Further, Assignor agrees to cooperate in any such actions to the extent reasonably required by Assignee to enforce the rights transferred hereunder.
