NOW, THEREFORE for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, it is hereby agreed as follows:



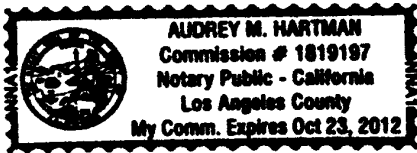

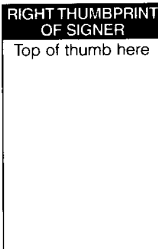
